Accreditation demonstrates that Maryville is committed to reducing risk, addressing health and safety concerns, respecting cultural and individual preferences and providing the best quality of care.

CARF International identified the following strengths in their report:

State and Federal Update to Combat the Opiate Epidemic

Gov. Chris Christie officially categorized opioid abuse as a public health crisis when NJ's overdose rate rose to twice the national rate. Calling for the legislature to pass a bill within 30 days to solve this public crisis during his State of the State address, the state legislature drafted a bill which was approved on February 6th.

According to the bill, the doctor is required to record the patient's medical including abuse history, substance addiction [before writing the initial prescription], and discuss the alternatives to opioids and explain the risks of getting hooked as a patient. The patient, or the patient's guardian if the patient is a minor, also must sign а document acknowledging the risks of developing a physical or psychological dependence on the controlled dangerous substance and alternative treatments that may available.

The bill requires doctors treating people suffering from acute pain to limit an initial prescription of pain-killing opioids to five days, but this does not apply to hospice or cancer patients, or to people living in nursing homes. If after the fourth day the patient requires more relief, the prescription can be renewed without the patient owing a second co-payment.

President Trump recently spoke out about the opioid crisis. "The opioid crisis is an emergency and we're going to spend a lot of time, a lot of effort and a lot of money on it."
